

Terms & Conditions

- All prices are quoted excluding VAT.
- All prices are quoted PER PERSON PER NIGHT unless stated otherwise.
- If, for any reason, you are not able to harvest one or more of the animals in your package, you will be credited for the package value of the animal to use towards a different animal or to be used toward the total amount owing at the end of your hunt.
- You are regarded as a hunter as soon as you make use of a gun and move into the hunting field.
- The hunter's tariff is applicable for the duration of stay and not only on the day of hunting.
- Hunters take full responsibility for the estimation of horn lengths of animals shot.
- Any blood/hair/bones of the animal found at the spot where the animal was standing on shooting is a sign that the animal has been shot and therefore will be seen as hunted and charged for.
- Your trophy mounting or handling (dip and pack for international visitors) and export will be charged by the company chosen and not by Siswati. Payments must be made directly to these companies.
- A deposit will be required to confirm your booking; you will be notified of this amount once a booking form (ZAR) has been received.
- No refunds are given on deposits if your trip is cancelled within 6 months of the date of commencement of the safari. In the event that this occurs, you can use your existing deposit to secure another trip at a future date.
- If you wish to cancel your trip more than 6 months in advance of the commencement date, you will be entitled to a full refund, or you can use your existing deposit to secure another trip at a future date.
- A breakage deposit of R1000 will be charged and will only be refunded after the duration of your stay once an inspection has been done and no items are found to be broken, damaged or gone. A suitable amount will be deducted from breakage deposit before refund in the event of any damage, breakage or lost items.
- Balance should be paid at the end of your stay before leaving Siswati Hunting Safari via EFT or cash. This includes hunter's tariffs as well as costs of all Hunted animals.
- A minimum booking of 6 people (for a group larger than 6) is required at the River Lodge to qualify for use of the River Lodge facilities.
- Groups smaller than 6 people are required to fully book out the River Lodge to qualify for use of facilities at River Lodge.
- Please respect all our staff and facilities and take care of them as if they were your own but please leave them with us on your departure.
- If something has been broken, we rely on your honesty to report it to us.
- If you have any concerns or problems feel free to talk to us or contact the owner at any time, if not present.
- Please note that strictly no alcohol will be allowed on any vehicle where there are firearms present.
- Siswati Hunting Safaris cannot be held responsible for any loss, damage, illness, injury or death resulting from anything that occurs while on safari. Any extra expenses or losses incurred by the client as a result thereof will be for the client's own account.
- All clients are responsible for arranging their own accident and travel insurance.
- All hunters and observers/spectators will be required to sign an indemnity form prior to arrival.
